



EXECUTIVE SUMMARY

LVCC sponsored a Crime and Personal Safety Seminar at Advocate Illinois Masonic Hospital on Wednesday, October 10, 2007. To announce the seminar, LVCC sent an email on October 7, 2007 to 1,958 residents and business owners in Lake View to get their opinions on Crime and Personal Safety in Lake View. No one received any compensation for their participation in the survey.

As of October 13, 2007, we had received a total of 184 responses to the survey, all but two came from individuals who were already on our database. Because of the low occurrence of anonymous surveys, all responses are included. We did limit one response per computer via cookie technology.

Almost three-quarters of the respondents had lived in Lake View for more than 5 years. Responses came in from all branches and were generally middle aged adults. One-third of the respondents indicated they personally or their immediate family witnessed or were a victim of a crime in Lake View in 2007.

In terms of satisfaction with the City of Chicago in 2007:

- Most satisfied with how addressing Gang Violence (31% either very satisfied or satisfied) and Prostitution (28% very satisfied or satisfied)
- Least satisfied with how addressing Personal Assaults (56%) and Graffiti (46%)
- Low awareness of how addressing Identity Theft (43% don't know)

Compared to prior years, 2007 perceptions are:

- Better than prior years with Gang Violence (16% feel better)
- Worse than prior years with Personal Assaults (58%) and Break-In's (39%)
- Low awareness of Identity Theft and Prostitution changes year-over-year

In terms of importance, the number of people rating these in their "Top 3" (of 10):

- Personal Assault (Armed Robbery / Rape / Violence) (114 responses)
- Break-in's (Theft from home) (87 responses)
- Gang Violence (42 responses)
- Traffic, Bike and Pedestrian Safety (38 responses)
- Public Nuisance (Noise / Urination) (36 responses)
- Drugs (29 responses)
- Theft (car/bike) (27 responses)

Support for Police Cameras at major intersections received the most votes.

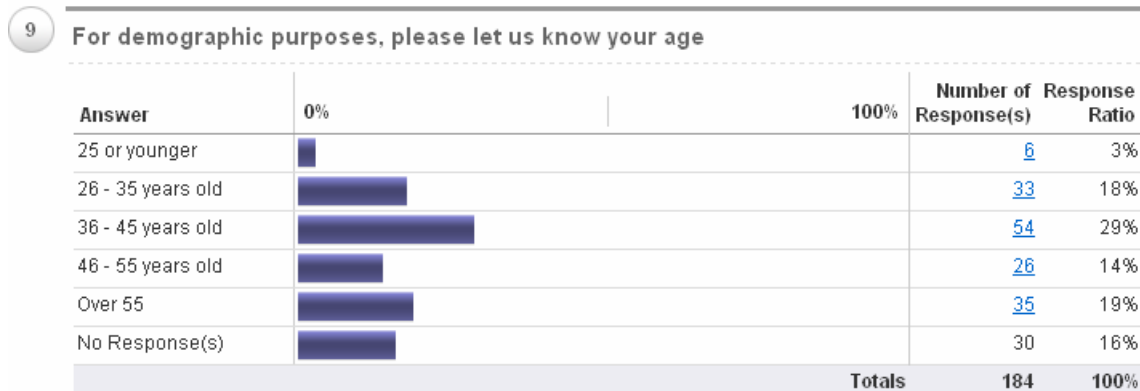
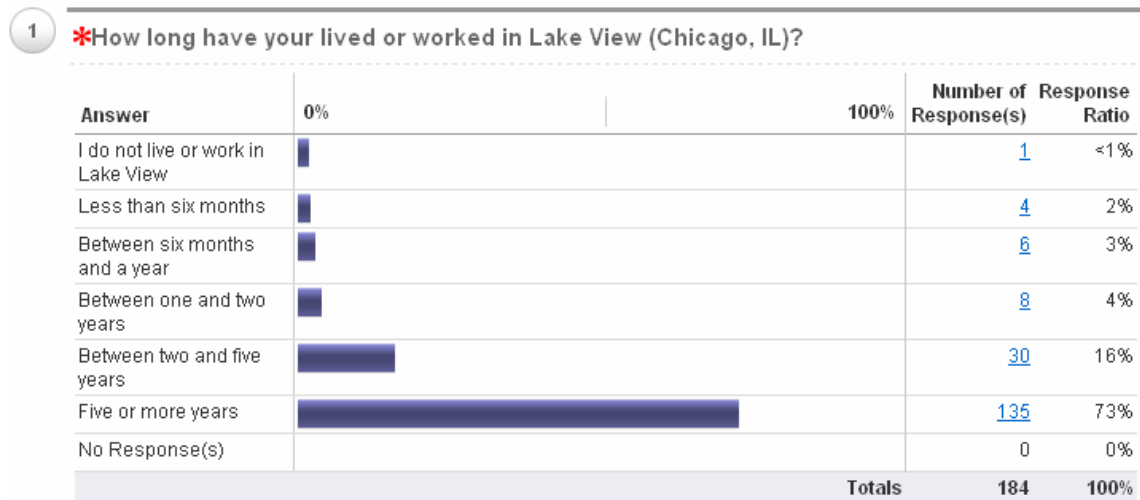

Answers

Drunk & disorderly; public urination & other such nuisance crimes

Something that looked like a drug deal handoff (but drugs not actually seen, so may not count)

Folks running red lights, speeding, parking in no-parking zones.

Garage break-in. Significant damage to door, but only minor items taken.

car vandalism

I was home and heard a loud noise from upstairs, it was a quick break in. They entered between 10:55 and 11:05am. The girl was out of town.

Also, I manage M2 Boutique at Eddie and Southport. There were 2 gang cars out front casing the store on Saturday 10.6.07. Police were called and they drove off.

I have heard about a lot more break ins from my customers and neighbors.
The worst ever.

A robbery at my place of business, and a breaking and entering- In both instances, precautions were taken and ADT was the means by which I was alerted.

Two friends and I were walking down Roscoe between halsted and browadway and 5 guys (probably 18-20 years old) jumped out from behind the bushes and punched my guy friend in the face (probaby a hate crime because my friend is gay.) Then they ran across the street and beat up two other people who were carrying their groceries home

My bike was just stolen Friday and my car has been broken into, I've had my front Grill of a VW Jetta stolen, and a hit and run.

Business burglarized 5 times. Witnessed assault and batteries as well as being personally assaulted.
Loitering.

One of my brothers had his bike stolen from his apartment on N. Pine Grove.
Another had his business robbed on N. Halsted.

No comment

Our 11 year old daughter was sexually harassed by a man on a bicycle while walking home from her bus stop which is at Hawthorne school.

petty crime on halsted ---petty crime on broadway--and in the general area -by people who travel into the area and just hang around--selling drugs --and prostitution

Walking with my now-wife eastbound on Roscoe between Clark and Halsted. Approached by two young African-American males. As we walked by, one of the individuals grabbed my shoulder and put a gun in my face and demanded my money and wallet. CPD responded quickly, but did absolutely no follow up and my repeated calls to inquire about the status of the investigation were referred to detectives who did not follow up. On a less serious note, I have had my car vandalized twice in my parking space.

Public drunkenness, fighting, urination, noise

Witnessed and reported post-Cubs game fans (1) defacing cars on street; (2) lighting fireworks off in street and near parked cars; (3) public urination on public way or in alleys

Fist fight--police arrived quickly and made arrests.

Occassional drug use in the park next to our home on 926 w. fletcher - we simply ask people to leave when

we see it because we doubt police can arrive in time to do anything....

tagging on my business store front.

Theft of employees handbags by con artists.

Victim of counterfeit \$50 bill passing.

continual destruction of flower pots outsided.

Bike stolen out of basement.

The person kicked in the front door but ran when the alarm went off. The police came, and they waited for my brother to come from the suburbs as we were out of the country. The police thought the person rings the bell and when no one answers, he attempts to get in.

I know of a couple of muggings and one gentleman that sold tickets to an event that didn't even exist.

Our car was broken into, radio stolen when parked behind our house.

Our back door window was smashed in, the intruder could not get in.

Our car was stolen from the filling station when we were putting air in the tires.

My girlfriend lives in a building that has frequent drug deals. As part of the fallout from this, various people have been hanging out in the area, and five bikes have been stolen from the bike room, as the 'dealer' likes to leave a back entrance door open so his 'clients' can have easy access to him.

Garage break in. Petty theft only.

My neighbors saw someone trying to climb in my window, they did not call police as he ran away.

I have witnessed men urinating in public on my property on several occasions. A bike was stolen from my gangway. (It was not locked up tho.)

Drunk climbed onto my balcony at 1am, ounding on the balcony doors and screaming for someone named "Teessa." Cops came, but he was gone by the time they got there. My car was also crashed into on the street in August, but the man left a note and was very nice about the whole thing.

car theft

I own a store and continuously witness cubs fans vandalizing my and others properties... the police don't seem to think it's important though. Maybe they can clean up the vomit, urine... fix all the things they break. Then they will care more.

My store was broken into and I got a ticket for a false alarm! The police didn't even shut the door when they left.

Attempted break in to my apartment.

After gay pride parade there was a fight between two men in a car in front of my house at 710 Roscoe Street.

The police eventually came. I'm not sure if any one was arrested.

Our building at 3222 N. Sheffield was "tagged" four times this year - on two occasion it was reported to police. Our building at 3216 N.Sheffield was broken in to - thieves robbed an atm at that location and did physical property damage.

Garage was broken into. Was told in the lobby of the police station on Halsted and Addison to call 911. From the lobby of the police station. I was astounded.

Bike theft. Several bikes stolen from garages in alley near me. Lots of homeless people constantly loitering in alleys, mostly when dark. Police didn't care at all because not serious crime.

A 30-something intoxicated white male punched and thereby shattered the glass of our front door.

How satisfied are you in how the the City of Chicago is addressing the following issues in 2007 in Lake View?

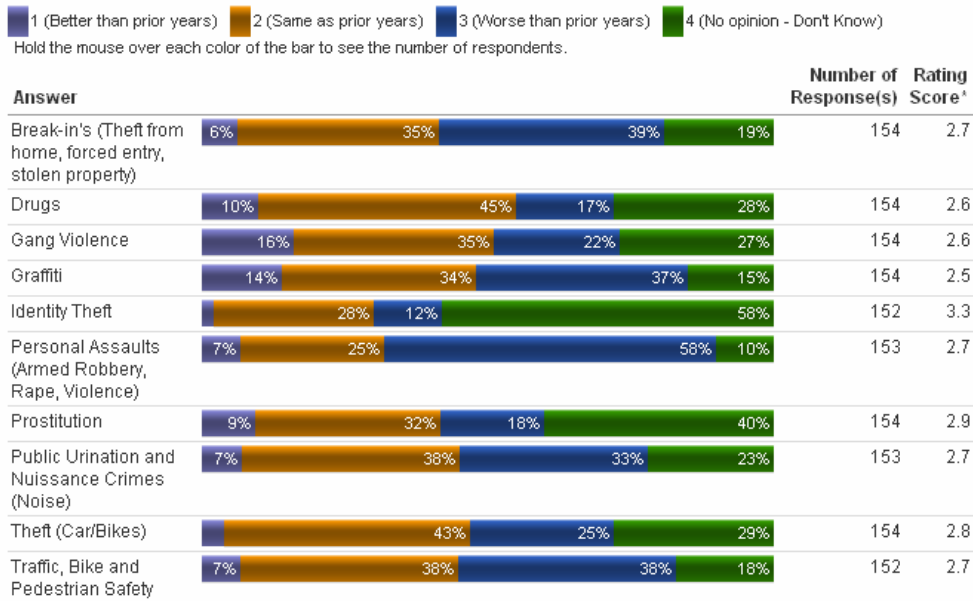

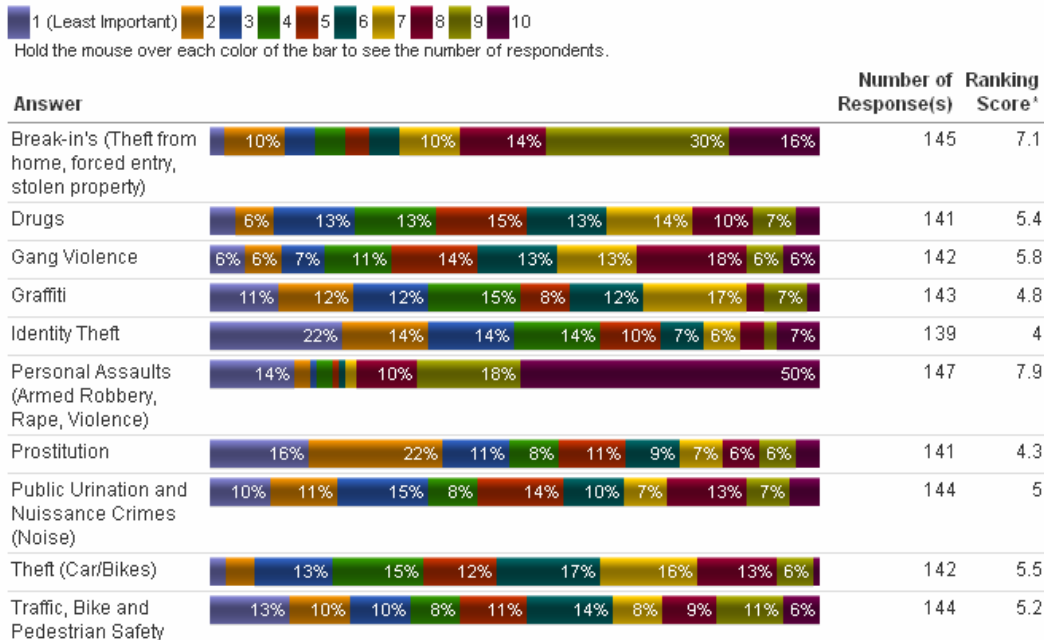
