**LAKE VIEW CITIZENS' AWARD
BONNIE LERACZ**

Bonnie Leracz moved to Lake View in 1990. Owing to the splendid example of her neighbors, Christa and Hans Boden and Jean and Bill O'Neill, she became active in East Lake View Neighbors (ELVN) and was elected Treasurer in the late 90's. Appointed Chair by the Board in 2003, Bonnie began representing ELVN on the LVCC Board and was appointed Secretary. In those community service roles, Bonnie worked to strengthen communication between the various interests operating within Lake View to bring community resources to the membership, to donate to local charities, to support the efforts of city services and the police, and to be always mindful of improving the quality of life in Lake View for its residents and business community.

Bonnie has been a volunteer Minister of Care St. Joseph Hospital; lector and Eucharistic minister in her parish St. Mary of the Lake; representative on the Greeley School Local School Council; leader catechist in SPRED, a program to offer small faith communities to people with mental retardation, and trustee of the University of St. Francis, Joliet, IL.

**LAKE VIEW CIVIC AWARD
PASTOR GEORGE RICE**

In November 2003, Pastor George Rice celebrated 50 years in ministry—10 years as youth pastor at the Addison Street Baptist Church and 40 years as pastor of the Addison Street Community Church. Not only has Pastor Rice been involved in these two churches, but also in the community: Chicago Public Schools, Park District, Boy Scouts, Lake View Kiwanis Club, Chicago Police Department, Fellowship of Christian Peace Officers, local politics (both sides of the aisle), North Park University, you name it—he's participated! In fact, in recognition of his service, the city has even renamed Addison Street at Hamilton Avenue "Honorary Rev. George Rice Way."

Rev. Rice has also served as the Vice-Chairman of the Beat Rep program, which was the forerunner to the CAPS program. He is a member of the Chaplains' Unit of CPD, having been appointed in 1980. He has served as Chaplain to the Fellowship of Christian Peace Officers. Rev. Rice also has served as a member of the Illinois Law Enforcement Commission during the Governor Ogilvie administration, both on the advisory board and the regular board. Pastor Rice served as the LVCC chairperson of the 23rd District Steering Committee.

In Scouting activities, Rev. Rice was the recipient of the Silver Beaver Award in 1960. He has been a loyal supporter of Boy Scout activities in the Chicago Area Council. While serving as a youth pastor, he was responsible for two Explorer posts, a Boy Scout troop and a Cub pack. One of the achievements of his Scouting career is that 25 of his Scouts received the God and Country Award.

Rev. Rice is happily married to his wife Marilyn and has two daughters, Barbara and Annie, and one son, Rev. Gary Schroeder, eight grandchildren and one great grandchild. Lake View Citizens' Council is proud to present Pastor George Rice our 2006 Civic Award.



BELMONT HARBOR NEIGHBORS

Belmont Harbor Neighbors has had a very successful 2005 – 2006 year. After much study, we voted to back a new zoning map developed by Alderman Tunney for the areas between Belmont, Roscoe, Broadway and Halsted. We actively backed the re-construction of the children's play lot at Roscoe and Lake Shore Drive. In November we held our annual food drive for the Lake View Pantry at Treasure Island. We have increased our e-mail mailing list to over 200 people and have a new web site: www.belmontharborneighbors.com. Our representatives to the 44th ward CDDC, Ronald Baker and Diane Kuta, have been very active in looking at the future of development in the 44th Ward.

CENTRAL LAKE VIEW NEIGHBORS

Central Lake View Neighbors is bounded by Diversey to Belmont and Racine to Halsted. The branch meets the second Thursday of each month at Advocate Illinois Masonic Hospital. CLVN is in the process of starting a new website.

CLVN has elected new officers and has been active in the community. Area directors were elected and will act as ambassadors for their areas, working to recruit new members. An outreach was done to over 100 businesses to encourage them to join.

CLVN formed a planning and zoning committee which addresses all zoning variances and zoning requests. CLVN hopes to have a fundraiser with Agassiz School by selling flowers and plants this spring. CLVN hopes to work on issues including beautification and green space. A membership committee was formed to encourage residents to join the organization.

EAST LAKE VIEW NEIGHBORS

East Lake View Neighbors (ELVN) dealt with issues regarding development, North Sheridan, the Hotel Chateau, expansion at Wrigley Field, increased height for the rooftop businesses, a street fair on Sheffield, the Buffett concert at Wrigley, planning, and regulation of informal businesses. Through information sharing at General Meetings, members were able to trade views with local officials and developers. Members were also offered opportunities to volunteer to serve local outreach groups such as the National Runaway Switchboard and C.A.U.S.E.S. A local source of pride is the restored Lake View Presbyterian Church. Pastor Joy Douglas Strome presented plans for the now-completed restoration along with a history of the church's presence in East Lake View.

Fundraising included a successful Oktoberfest and collecting food and monetary donations at Thanksgiving time for the Lake View Pantry. Besides the Pantry, Greeley School, the House of the Good Shepherd, Lake View Presbyterian Church, and Gill Park benefited from the proceeds of Oktoberfest.

HAMLIN PARK NEIGHBORS

All meetings for Hamlin Park Neighbors are held at the Hamlin Park Field House and begin at 7:30 PM. General Meetings are held on the 4th Tuesday of the month and are open to the public. Board meetings are open to all members though dates may change. To be notified Board meetings dates/times by email, please contact hp@lakeviewcitizens.org. Hamlin Park neighbors is the community voice for citizens who live between Belmont, Ravenswood, Diversey, and the Chicago River. The Hamlin Park neighborhood is divided between the 1st Ward and 32nd Ward as follows: North of Wellington Avenue- 1st Ward includes any addresses either west of Clybourn or west of

Oakley, 32nd Ward includes those to the east of both Clybourn AND Oakley. South of Wellington Avenue-1st Ward includes addresses west of Damen, 32nd Ward included those east of Damen.

HAWTHORNE NEIGHBORS

Hawthorne Neighbors General Meeting took place on Tuesday, January 17, 2006 at Resurrection Education Building (1050 W School Street). Membership runs from November 1st to October 31st of each year and covers residents and businesses between Belmont to Addison and Clark to Racine. Individual memberships in Hawthorne Neighbors are \$5/year.

Major issues in 2005-2006 centered on quality of life issues. Some of these issues focused around events such as the annual Garden Walk, the LVCC Street Fair and the CLMA Street Fair. The street fairs have presented some negative issues that are being dealt with. We also discuss the development of the neighborhood and of the businesses on Clark Street. The new Zoning Ordinances have developers looking for variances and we monitor "Incidental liquor license applications" and sidewalk cafes.

Many of our concerns coincide with other branches' concerns: housing diversity and density, developers' proposals for town-homes and three flats, trash/noise/public drinking along our business strips, liquor license and beer garden requests, poor mail delivery and parking. We will continue to meet the challenges to improve our living environment both individually and with the other branches of LVCC.

SHEIL PARK NEIGHBORS

For the second half of 2005 and the first half of 2006, SPN has continued to work with residents and Southport business owners to maintain a harmony for everyone. Several variance requests were referred to SPN by the Alderman's office. Each was asked to attend meetings and present a case for the variance and was then voted on by the neighbors. Sidewalk cafe size and placement were an open issue last year and continue to present challenges for 2006. As well, speed bumps on School Street were discussed at several meetings, but in the end the neighbors did not favor installation if them. The approved option was to install "speed limit" and "slow" signs along with trimming of the trees along the street. Lastly, SPN is also engaged with the developers to reach a compromise for development of the property at Ashland and Belmont. While this is not within the boundaries of Sheil Park, the neighbors are concerned with the traffic and congestion that will accompany any development at that intersection.

SOUTH EAST LAKE VIEW NEIGHBORS

In the past year, South East Lake View Neighbors (SELVN) has continued working on several multi-year ongoing issues. SELVN worked extensively with the alderman's office to achieve rezoning of residential areas between Broadway and Halsted. Areas east of Broadway are planned for zoning re-evaluation in the future. Representatives from SELVN have been active in the discussions of the planned development of Resurrection St. Joseph's hospital and in the 44th ward master plan preparation initiated by the alderman's Community Directed Development Council. Efforts to landmark several blocks within SELVN are also actively being pursued.

Last December, after serving successfully for six years as president, Robert Clarke transitioned to the Office of Vice President, exchanging positions with York Chan. The organization also welcomed several new board members. A major goal this year is to work more with other neighborhood groups, the chamber of commerce, and local schools. Several community-wide forums are being

planned by SELVN for this year, addressing CTA Brown Line reconstruction and redevelopment of the Dominick's property.

SOUTH LAKEVIEW NEIGHBORS

- 1) Continued zoning review requests. It appears that every real estate purchase is followed by an up-zoning request from the new owner. We have resisted any up-zoning changes on "knock-down" property issues.
- 2) We are consulting with WLN on the St. Luke's Senior Center and the Centrum LaSalle Bank Development. Even though, not within our boundaries, we have dealt with the Renaissance Group on the Senior building on Belmont and the LaSalle Bank issue will affect all in the neighborhood.
- 3) Once again, we sponsored a talk by Alderman Matlak at our November membership meeting.
- 4) We are getting information out on the Inclusionary Housing Ordinance before the city Council. We intend to have a presentation and vote at the May membership meeting.

SOUTHPORT NEIGHBORS

We have a new president: Jill Peters. We have formed a retail committee for Southport. It is headed by 3 board members: Maria Betti, Kelly Lawrence and Lisa Santos. Also in monthly attendance are Alderman Tunney, Heather Way and Chris Irwin (a real estate broker). They are modeling this Committee after the very successful Retail 47 group in Alderman Schulner's ward. Some of the goals are to be proactive in finding complementary businesses for our street and to work with Jewel/Osco on their plans for the future and creating a harmonious relationship with our businesses on Southport.

We also have been working on our strengthening our relationship with the Clark Street businesses. And trying to work with these businesses to find a balance between their business needs and the needs of our residents.

We continue to attend the CDDC meetings monthly. Our delegates are Jill Peters, Peter Uliasz and Sally McPherrin. We have finally completed a master plan for our ward. We sponsored the "Greystone Initiative" with Alderman Tunney, which is a campaign to bring awareness to developers and the public of the importance of these historic buildings. We just saw in the news that a more formal initiative is being made official later this year. Our efforts in bringing this to the forefront are being rewarded!

We are in the process of working on "Summer on Southport," our summer children's festival. We are working with a committee that consists of board members and businesses to make sure this festival is successful for our organization as well as our Southport businesses. Proceeds go to our organization to plan for next year's events, and to benefit Blaine School.

TRIANGLE NEIGHBORS

The residents and businesses in Triangle Neighbors rallied around the efforts to build a community park to make 2005-2006 a huge neighborhood success. First, this past June 2005, NeighborSpace closed on the first half of community garden at 815 W Roscoe. This urban Eden will become a sanctuary in a community represented by so many brand new four-story condominiums. Throughout the year, TN held a series of fundraising events including:

- A Lemonade Stand and Cubs Rooftop Ticket Give-away (in conjunction with the Lake View Garden Walk)

- A Halloween Parade – definitely *the* major event Halloween night in Chicago
- Our first ever Charity Bachelor Auction (for him and for her) raising \$10,000 in one night.
- Weekly fundraising meetings with potential contributors to our park acquisition efforts.

TN has focused on communicating better with its members. There is now a regular eNewsletter (Triangle Tales). Triangle events are regularly covered by local news programs and have articles in the Tribune, Sun Times, and neighborhood and gay press.

Alderman Tunney rewarded our diligent efforts to make our streets safer and cleaner. We held community forums on graffiti and community safety. The new curbs and sewer drainage correction project for Roscoe Street is nearing completion and the two speed humps (just past the alley and at the 900 block) should go in the Spring 2006. Several other streets in Triangle were also re-paved.

WEST LAKE VIEW NEIGHBORS

In the last year, West Lakeview Neighbors (WLVN) discussed a number of development issues, reviewed sidewalk café licenses and street fairs such as Rock around the Block and had security updates from the 19th Police District and Attorney General's Office. The Schoolyard Tavern's expansion was a big issue last two years. The current focus is on the proposed 108-unit senior assisted living facility by Renaissance and St. Luke's at 1501 W. Melrose and the proposed Centrum development on the LaSalle Bank property at Ashland and Belmont, which includes a 7-story condo and commercial building, an office building and condos on Melrose.

WLVN regularly meets with Aldermen Tom Tunney (44th Ward) and Ted Matlak (32nd Ward). Once a year, State Rep. John Fritchey and Cook County Commissioner Mike Quigley give us legislative and county updates. In March 2006, we elected a new board. WLVN meets the third Wednesday of every other month at the Lincoln Belmont Library (1659 W. Melrose). For more information, please see our website, www.wlvn.org.

ANTI-CRIME COMMITTEE

This year was a busy year for the Anti-Crime Committee. Three forums were sponsored in the area. A forum was held informing the public of the laws regarding "Sex Offenders." A second forum was sponsored by LVCC on "Identity Theft." A third forum was held which addressed "Graffiti." Each of the forums had presenters and provided informative material to those in attendance. Additionally, LVCC donated funds to purchase two bicycles for the police to use in the 23rd District. Police are able to use the bicycles as part of their neighborhood patrol. The police on bicycles provide a good presence for the neighborhood.

BILL JARVIS BIRD SANCTUARY

The Bill Jarvis Migratory Bird Sanctuary has survived the worst drought in a decade thanks to the efforts of our volunteers. During the long hot summer, watering crews saved vulnerable newly planted shrubs and trees. Native plants and grasses showed their evolutionary adaptation to the Midwest "climate from Hell" by booming and providing seed for the fall migration. We continued to battle the aggressive invasive species that crowd out the food producing species the birds so desperately need.

In November 2005 Jarvis received \$2,600 celebrating the birthday of your project chair.

These funds are supporting the volunteer component and providing seed plants and tools. The Chicago Park District has finally contracted help for the Nature sites and we expect to make even more progress toward our goal of a sustainable ecosystem.

Thanks to State Representative Sara Feigenholtz Jarvis received a grant of \$20,000 to winterize our storage shed. A new year round bathroom, windows, etc. will provide a much more pleasant work environment for all. Please join us on May 27, June 10, July 8 and August 12 for details call 773 327 5053.

OPERATION MITTEN

Each year, LVCC solicits donations from residents and the business community. Last year, we raised \$1,000. The money was used to purchase hats and mittens for underprivileged children in the neighborhood. The items were donated to Holiday Parties at the 19th and 23rd Districts of the Chicago Police Department. Additionally, items were provided to the officers in the 19th and 23rd District to distribute to children on their beat who were in need of a hat, glove, or mittens. This program was started by LVCC many years ago to foster a relationship between the police and children in their districts.

COMMUNICATIONS COMMITTEE

The Communications Committee continued the work started in 2004-05 to put in place the building blocks to communicate more effectively and more frequently with residents and businesses in Lake View.

First, we upgraded the LVCC web site (www.lakeviewcitizens.org) and created an interactive home page that allows site visitors to more easily see which neighborhood group they belong to. Site visitors can literally drill down on a map to learn the name of their neighborhood organization, its meeting day and time, and how to contact them. We created for each of our 12 branches an email account (branchname@lakeviewcitizens.org) that could be forwarded automatically to up to two different email contacts within each branch. We continued the practice of posting branch newsletters and announcements to the extent they were forwarded to us, and the website "Important Announcements" page was updated a minimum of twice a month every month.

Second, we developed several new marketing collateral pieces to help improve community awareness of LVCC and acquire members on behalf of the branches. The first piece (the postcard) can be mass-produced for distribution in street fairs and at other community events. People who respond to the postcard are added to the LVCC email list (as well as their respective branch communication list). The second piece (the brochure) articulates the mission of LVCC, some of our accomplishments, and contains an up-to-date map of all the branches. We designed the brochure with space for each branch to customize it with their name, regularly scheduled meeting day/time/place as well as how to contact them. The third piece was a poster that again contained a map of the LVCC branches with the message to "Get Involved". We also produced a giant banner (that was hung on Broadway for the entire month of February 2006). All the pieces have the same "look and feel" to develop a consistent set of images across all the communication channels.

Finally, we formalized our monthly LVCC e-newsletter, the e-Citizen. We now directly distribute this to hundreds of residents and businesses on a monthly basis and highlight both community-wide and local events and encourage each of the branches to forward it to their respective lists. TAX REFORM ACTION COALITION

TRAC and the 30 community groups from across the city that make up the coalition worked hard to get the 7% solution renewed. TRAC launched a successful campaign in January that involved sending thousands of postcards to Springfield called the "Blizzard Campaign." Leaders from these community groups picked up postcards and got to meet their counterparts at a "social" where they were encouraged to keep going by Assessor Houlihan, Sen. Cullerton, Rep. Fritchey and Ald. Matlak. It worked because the Senate passed the 7% solution with a majority vote!

It was a much different story when the bill got to the House. The bill did not have the support of Speaker Mike Madigan and 12 Chicago Democratic Representatives. They sided with the Big Business groups that lined up against the tax relief for homeowners. Jerry Roper, President of the Chicagoland Chamber of Commerce, has described this bill as an attempt to keep taxes low for **"a select subset of affluent homeowners."** The Metropolitan Planning Council (A+ Illinois) stated in it's February legislative agenda that they did not want the 7% renewed because they wanted to ease the property tax burden on commercial and industrial owners.

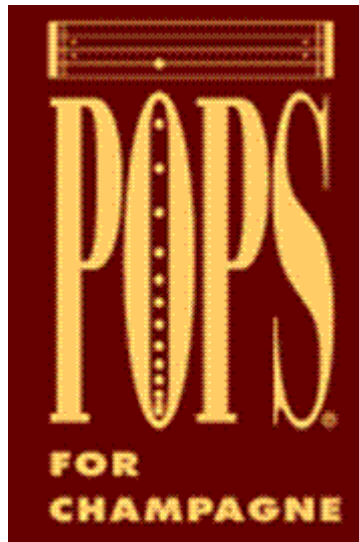
